Needs and Challenges

EU4Health is a welcome opportunity to build better resourced, equal and resilient health systems. However, to achieve its objectives and to improve all European's health, while responding to their needs, it is necessary to fully involve health civil society in the development and implementation of its Work Programmes (WPs). This can be achieved by ensuring budget allocation to operating grants (OGs) for civil society organisations (CSOs) and more meaningful involvement and consultation.

Description of solutions proposed including (1) objectives, (2) outcomes, and (3) EU added value (i.e. how the action brings value at EU level, which is additional to the value that would have been otherwise created by Member State action alone)

Starting with the WP2022, we call on the EC to:

- Allocate DG SANTE human resources, attention and EU4Health funding to address information prevention and care of respiratory diseases, which are responsible for 1 in 8 deaths in the EU (without COVID19 deaths), cost more than €380bn a year in the EU, have been worsened due to COVID-19 and suffer from a persistent lack of priority.
- Restore operating grants for CSOs: abandoning OGs as a financing mechanism in favour of 'Action Grants' has devastating consequences for European CSOs, as it seriously reduces CSOs' capacity to support the achievement of many EU4Health's objectives as independent and expert key partners of the EU, able to reflect real-life perspectives of patients and citizens. - Ensure meaningful consultation with CSOs: essential to ensure the WPs will better respond to real needs for a more efficient use of the budget, leaving no disease areas nor population groups behind.
